Introduction







Growth through Collaborative Work




Autonomous drone network consist of self charging drone stations, monitoring and control setup for precision agriculture, emergency services, logistics, solar power plant maintenance and security applications.



Steel Industry

ZT acquired a nearly dying and dormant plant of steel production in 2019, it is now operating at 30 ton per day and results of 2020 has shown a Gross Profit of 40 Million SR. This has been achieved through change of leadership and operational style, this was a quick turn around and reached within period of less than 2 years, current turn over of this factory is 400 Million SR as reported in financial statements and a net profit of X.X Million SR is also reported for year ending in 2020. Steel mill is a producing and operating entity at the moment and it is expected that financial result for 2021 will be better than what is shown in 2020.

We use the latest technical means in the manufacture of iron, which guarantees complete perfection starting from the pallet, before heating up and even assembling and storing the finished product. This process is controlled, monitored and recorded through the control devices, which provides complete control and product quality, From securing the raw materials to the production of reinforcing steel.







Hospitality

A unique project of its kind is with Nozoul, ZT acquired this company as current management was unable to take this to operations and nothing was done at site. This project has witnessed some ground operations since change of management, and substantial progress on design, documentation and planning has been made so far. Funding was considered as primary hurdle and accordingly, funding arrangement is near to arrive, which will give a jump start. This project is expected to have 25 Billion as total revenue from its operation, and total constructed area is expected to be 1.2 Million Sq Meter. This project has potential for selling internationally, as Makkah is holy city of whole muslim world and many business houses tend to acquire space in Makkah.
